## MUSICBOX™ MANUFACTURER'S LIMITED WARRANTY

Medrad warrants each new MUSICBOX System (main unit) sold by Medrad and its authorized agents against defects in materials and workmanship, under, proper, and normal use and service, for a period of one year (12 months) from the date of installation on the Warranty Registration Form but will start no more than three months from the factory ship date. All accessory equipment: cables, headsets, ear cushions, ear tips and extension tubing will be covered for a period of three months from the date of installation on the Warranty Registration Form but start no more than three months from the factory ship date.

During the Warranty period, Medrad will make no charge whatsoever in fulfilling the terms of the warranty. Medrad will at its sole discretion, repair or replace, without any charge for parts or labor, any component or components which, in Medrad's judgment, are defective in material or workmanship. There will be no charge for any action deemed necessary by Medrad, including parts, travel, or labor to fulfill the terms of the warranty, during normal business hours (8:30 am to 5:00 pm, local time, Monday through Friday, except holidays) excluding those items listed under "Exceptions."

This Warranty shall not apply to any MUSICBOX, component, or subassembly which has been repaired, altered, misused, or abused in any way as, in Medrad's judgment, to affect the operation of the system, component, or subassembly safety or reliability.

The terms of this warranty may be superseded by specific warranty terms listed in any current contractual agreement between Medrad Inc. and Medrad's authorized agents. Medrad also neither assumes nor authorizes any other person or corporation to assume or commit for us or any other warranty responsibility or liability of any kind whatsoever in connection with the sale or use of our MUSICBOX system, components, or subassemblies.

THIS LIMITED WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, WHETHER ORAL, WRITTEN, EXPRESSED, OR IMPLIED, INCLUDING WITHOUT LIMITATION, WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, AND ALL SUCH OTHER WARRANTIES ARE EXPRESSLY EXCLUDED. MEDRAD'S OBLIGATIONS AND BUYER'S REMEDIES ARE LIMITED TO THOSE SPECIFICALLY SET FORTH IN THIS LIMITED WARRANTY. MEDRAD'S LIABILITY, BASED ON ANY THEORY, SHALL NOT EXCEED THE PRICE OF THE INDIVIDUAL MUSICBOX SYSTEM WHOSE DEFECT OR DAMAGE IS THE BASIS OF THE CLAIM. IN NO EVENT SHALL MEDRAD BE LIABLE FOR ANY LOSS OF PROFITS, LOSS OF USE OF FACILITIES OR EQUIPMENT, OR OTHER INCIDENTAL OR CONSEQUENTIAL DAMAGES. Some states do not allow the exclusions on limitations of incidental or consequential damages, so the above limitations may not apply. This limited warranty gives the buyer specific legal rights and the buyer may have other rights.
